Each contestant will be given a set of **FORTY (40)** sealed and uniquely-numbered envelopes. Each set of **40** envelopes will consist of:
 Five (5) of the envelopes will contain the message “I Love Rock N’ Roll” representing the Grand Prize;
 Six (6) of the envelopes will contain the message Rock N Roll representing the First Prize;
 Nine (9) of the envelopes will contain the message guitar representing the Second Prize;
